Interview of Dr Raphael Louis

Q1) Briefly explain about your research expertise

A: As a Certified Global Healthcare Reform Expert through OnFrontiers, whereas a Knowledge Network of International Development experts and professionals, my primary area of focus is to collaborating with governments and civil societies to build better healthcare systems, putting the health and well-being of populations at the core center of public health policy. My most current research is based on Cannabidiol (CBD), which been touted for a wide variety of health issues, but the strongest scientific evidence is for its effectiveness in treating some of the cruelest childhood epilepsy syndromes, such as Dravet syndrome and Lennox-Gastaut syndrome (LGS), which typically don't respond to antiseizure medications. In numerous studies, Cannabidiol (CBD) was able to reduce the number of seizures, and in some cases, reduce chronic pain, anxiety relief, anti-seizure, neuroprotective, and cancer treatment. I have also launched a Legislative project though the Government of Canada, to amend the regulation of CBD and classify CBD as a natural health product..

The New International Economic Order (NIEO) was a set of proposals put forward during the 1970s by some developing countries through the United Nations Conference on Trade and Development to promote their interests by improving their terms of trade, increasing development assistance, developed country tariff reductions, and other means. It was meant to be a revision of the international economic system in favor of the Third World countries, replacing the Bretton Woods system, which had benefited the leading states that had created it. The term was derived from the Declaration for the Establishment of a New International Economic Order, adopted by the United Nations General Assembly in 1974, and referred to a wide range of trade, financial, commodity, and debt-related issues (1 May 1974, A/RES/S-6/3201). This followed an agenda for discussions between industrial and developing countries, focusing on restructuring of the world's economy to permit greater participation by and benefits to developing countries (also known as the "North-South Dialogue").
